The County Planning Division has reviewed the additional project information as submitted on September 20, 2007; we find that it is complete for purposes of filing as of November 20, 2007.

Please be advised however, that in accordance with Section 65944 of the Government Code, the County may request the applicant to "clarify, amplify, correct or otherwise supplement the information required for the application." Failure of the applicant to provide such additional information in a timely manner could result in an extension of processing time or a recommendation for denial without prejudice by this Agency.

The next step in the permit process is for County staff to determine the appropriate type of environmental document for your project. In accordance with Section 15102 of the California Environmental Quality Act (CEQA) Guidelines, this determination must be made within 30 days from the date of application completeness, unless a 15-day extension is granted by the applicant.
